### Workshop Descriptions

#### **Part 1 – The Game of Gamblers (USDAA)**

**Sunday July 18, 7:30am - 10:30am**

This seminar will focus on the rules and strategy to perfecting the USDAA gamblers runs. Learn how to plan an opening so you can get to the gamble line just as the whistle blows, how to accumulate as many points as possible during the time allotted by the judge and what to do if you get to the gamble area too soon. We will also discuss handling do's and don't for the gamble course. Handler/dog teams will have several opportunities to perfect these skills on a gambler course

#### **Part 2 – The Game of Snooker (USDAA)**

**Sunday August 1, 8:30am - 11:30am**

Join us for a fun morning of Snooker strategy and practice. The game of snooker is named after the billiards game that is popular in Great Britain. Learn how to develop your strategy to accumulate as many points as possible during the time allotted by the judge by performing the obstacles in "Snooker" sequence. You will be ready for the upcoming fall USDAA shows and have fun with the game of Snooker.

#### **Part 3 – The Game of FAST (AKC)**

**Sunday August 15, 7:30am - 10:30am**

FAST is a game of speed, strategy and requires distance handling skills. This seminar will teach handlers how to finish your FAST course with all the points prior to that whistle going off. We will focus on the rules and strategy to perfecting the AKC game of FAST and have several opportunities to put your plan into practice.
